the date of demand of Government rates for the time being in force on Government  
loans in case I leave the institute during my probation period.

Whereas the Obligor is offered appointment for the post of Staff Nurse by  
the Institute by executing a service Bond to the effect that he/she will serve the Institute  
at least for a period of 2 years. If he/she fails to serve the Institute as per the terms and  
conditions of the bond he/she and/or his/her sureties jointly and severally will pay the  
Institute an amount of Rs.2,00,000/- (Rs. Two Lacs only) to the Institute.

And whereas for the better protection of the interest of the Institute, the  
Obligor has agreed to execute this bond with such conditions as hereunder are written.

And whereas the said sureties have agreed to execute this bond as  
sureties on behalf of the above bounded (Obligor) (\_\_\_\_\_).

Now the conditions of the above written obligation is that in the event of  
the Obligor Shri/Ms. \_\_\_\_\_ resigning from service of Institute or  
deserting the service or absenting from duty without sanctioned leave on any account or  
without returning to duty or absenting or overstaying without permission after the expiry  
or termination of deputation/leave or at any time within a period of two years after  
joining the service the Obligor and the sureties shall forthwith pay to the institute or as  
may be directed by the Institute on demand the said sum of Rs.2,00,000/- (Rs. Two  
Lacs only) together with interest thereon from the date of demand at Government rates  
for the time being in force on Government loans. Besides this the Obligor will be liable  
for disciplinary action as per rules.
