## 4. RESERVATION AND RELAXATION:

The reservation and relaxation in the upper age limit will be made only for the category of the posts reserved for such categories, as per the instructions issued by the Government of India from time to time.

The SC/OBC candidates applying for un-reserved posts are not entitled to any relaxation in upper age limit.

The claim of the candidate to OBC categories should be considered only when the same is accompanied by the certificate issued by the competent authority in the format prescribed by the Government of India and should have the clause of non-creamy layer.

## 6. OTHER GENERAL CONDITIONS:

(i). The above vacancies/categories indicative above are only tentative and are liable to change as per requirement.

(ii). Those candidates, who are employed in Central Government/State Government/UTs/Statutory Bodies/Research Institutes etc., should send their application along with Service/No Objection Certificate from the employer Through Proper Channel. One Hundred only) and other certificates and testimonials so as to reach this office on or before the schedule date.
