Sir,

I am to state that the Council at its meeting held on 29.10.38 considered the Council Inspectors report (6th & 7th Oct., 38) for purpose of recognition of Govt. Medical College, Chandigarh for the award of MBBS degree granted by Punjab University. The Council approved the following recommendations of the Executive Committee which I am directed to convey herewith for your information and necessary action:-

"The Executive Committee considered the Council Inspectors report (6th & 7th Oct., 38) and noted that the teaching staff which was earlier working on deputation basis from the neighbouring State now stands replaced with the regular staff appointed for Govt. Medical College, Chandigarh. The Committee also noted that the other infrastructure facilities such as beds, clinical material etc. is now adequate. In view of these facts, the Committee decided to recommend that Govt. Medical College, Chandigarh be recognised for the award of MBBS degree granted by Punjab University with 50 (Fifty) annual admissions."
