

**Dispose off the material of House No.III/3153, Sector 48, Chandigarh (As is where is Basis)**

Sealed bids are invited for the sale of material of House No.III/3153, Sector 48, Chandigarh lying in the basement of Block C, GMCH-32, Chandigarh **As is Where is Basis**.

**Other terms & conditions are as under:**

1. The Bids shall be in two Bid System i.e. Technical Bid (Envelope I) and Price Bid (Envelope II).
- (i). The Technical Bid should contain:-
  - EMD of Rs.2000/- payable in favour of the Director Principal, Govt. Medical College Hospital, Sector 32, Chandigarh in the shape of Banker Cheque/Demand Draft.
  - Copy of GST No.
  - Copy of PAN No.
- (ii). The Financial bid as per format attached.
2. The Terms and Conditions must be duly accepted and counter signed by the bidders.
3. The technical bid containing the above documents should reach this office physically by 19/06/22 upto 2:00 P.M. **No bids will be considered thereafter.** The technical bids will be opened on the same day at 3:00 P.M. Any representative who may wish to be present at the time of opening of bids can come at the time of opening of the bids with due authorization/proof of identification
4. The reserve price of the materials is fixed at Rs.30000/- and any bid offered less than this amount will not be considered for acceptance.
5. The security amount will be refunded to the unsuccessful bidders.
6. If the highest bidder after giving the bid back out then his/her entire security deposit will be forfeited.
7. The materials will be disposed off by **As is where is Basis**
8. The material should be lifted up by the highest bidder at his own cost including labour charges etc within Seven days on acceptance of his bid.
9. In the event of highest bidder fail to lift the materials the second highest bidder will be considered at the rate quoted by the highest bidder. Thereafter fresh bids will be invited.
10. The committee constituted for opening the bids will evaluate the bids and the decision taken by the committee will be final.
11. The successful bidder will be required to deposit 25% of the total tentative sale value within 12 hours after the issue of sale order alongwith Taxes and balance 75% will have to be before lifting the material.
12. The successful bidder shall also make the payment in the D.D.O. A/c No. **10413584255 (IFSC Code SBIN0010607)** of the department through on-line or in the shape of Banker Cheque/Demand Draft (in favour of the Director Principal, Govt. Medical College Hospital, Sector 32, Chandigarh) for the condemned materials/items
13. The desirous bidders can inspect the material to be auctioned on any working day except Saturday, Sunday and Gazetted Holidays for which they may contact in the office of Repair Section, Block C, Basement, GMCH-32, Chandigarh.
14. The rates should be quoted both in words and figure, failing which the quotation will not be considered.
15. The Technical and Price Bid may be addressed to the Director Principal, Govt. Medical College Hospital, Block-D, 1<sup>st</sup> Floor, Sector 32, Chandigarh.
16. The Technical and Price bids needs to be submitted in sealed cover separately supersubscribe "Technical Bid and Price Bid of Materials/Items" in the Repair Section, Basement, Block C, GMCH, Sector 32, Chandigarh.
17. The decision of the Director Principal of GMCH will be final and the Director Principal GMCH reserves the right to accept/reject any bid (including highest bid) without assigning any reason thereof.
18. All disputes will be subject to Chandigarh jurisdictions
