

OFFICE MEMORANDUM

Subject: Order in respect of Bond for taking Study Leave under rule 53(6) of the CCS (Leave) Rules, 1972 - pertaining.

The undersigned is directed to note that Government servants are allowed to avail "Study Leave" in terms of the provisions of rules 50-53 of the CCS (Leave) Rules, 1972. The officers shall take advantage of availability of Study Leave by Government Servant who is granted service in the relevant format prescribed for the said purpose i.e. Form 7-10 of the CCS (Leave) Rules, 1972.

(a) The said Bond executed by the Government servant requires putting in specified period of service after expiry of the Study Leave as prescribed by provisions of rule 50(3) of the said rules.

(b) It has come to the notice of the undersigned that, provisions of the "for cash" bond regarding disbursement and recovery of the same, Study leave, etc., are not clearly defined in the said rules. In this regard, there do not put in writing the period for the repayment period as indicated in the bond referred to them.

(c) In view of the above position, the provisions of the prescribed format of the Bond have been reviewed in consultation with the Department of Legal Affairs and it has been decided that the prescribed forms 7, 8, 9 and 10 of the CCS (Leave) Rules, 1972 may be revised by incorporating a specific clause confirming commitment of the Government servant to give his services after expiry of the Study Leave. The clauses of the revised formats are enclosed herewith. The grant of Study Leave shall continue to be regulated in terms of the relevant provisions of the rules as indicated in para 1 above. Ministry of Finance Affairs etc are requested to ensure that the necessary Bond in respect of grant of Study Leave under the CCS (Leave) Rules, 1972 may henceforth be obtained in the revised format.

(d) These orders are being issued after consultation with the C&AO of India in respect of persons serving in the Indian Audit & Accounts Department.

Normal arrangements for CCS (Leave) Rules, 1972 are being issued separately.

दिल्ली : सीसीएस (अवकाश) नियमावली, 1972 के नियम 53(4) के अंतर्गत अध्ययन अवकाश लेने के लिए बंधपत्र के निष्पादन के संबंध में।

अधोहस्ताक्षरी को यह कहने का निरेश हुआ है कि सरकारी सेवकों को सीसीएस (अवकाश) नियमावली के नियम 50-63 के प्रावधानों के अनुसार “अध्ययन अवकाश” का लाभ लेने की अनुमति होती है। नियम 53(4) के प्रावधान, इस अवकाश अवलम्बन के लिए जाने वाले सरकारी सेवक द्वारा निर्धारित संगत प्रपत्र अर्थात् सीसीएस (अवकाश) नियमावली, 1972 के प्रपत्र 7-10 में एक बंधपत्र के निष्पादन का अधिकार करते हैं।
