In supersession of this Administration's letter No. 99/1/04-UT FII(12)-2008/5425 dated 04.08.2008 on the subject noted above, it has been decided by this Administration to enhance the financial powers of various authorities in the Chandigarh Administration to sanction the reimbursement of medical claims submitted by the Government employees under the provisions of Punjab Services (Medical Attendance) Rules, 1940, with immediate effect, as under: -

Sr. No.	Authority	Amount of each claim
i)	Head of Office	Upto ₹ 10,000/-
ii)	Heads of Departments	₹ 10,001/- to ₹ 50,000/-
iii)	Administrative Secretaries	₹ 50,001/- to ₹ 1,25,000/-
iv)	Finance Department	Beyond ₹ 1,25,000/-

2. The claims involving relaxation of rules shall continue to be sanctioned by the Administrative Department with the prior concurrence of Finance Department as here-to-fore.


