

Sir,

With respect, it is to inform you that we, the retired employees of U.T. Secretariat, have formed an Association in the name of U. T. Secretariat Retired Employees, Welfare Association, Chandigarh and the same has been got registered with the Registrar of Firms & Societies i.e. Deputy Commissioner, Chandigarh, vide Regd. No. 4709 of 2017 dated 12.10.2017. We had been holding mandatory meetings for the last many months, and have now been able to achieve this distinction, for the first time since the inception of U.T. Secretariat i.e. 1966.

Sir, basic idea behind forming this association is to bring together the retired employees, who had worked for decades together while serving in Secretariat and there was no link between us. During this period, it was learnt that we have lost a number of colleagues, who breathed their last, as unknown death for us.

The next aim of the Association to stand by colleagues, who are in dire need, may be, on health grounds, financial position or if he is feeling lonely, with a purpose in view, we are holding regular meetings and have proved this to many colleagues.

In the meeting dated 6.11.2017 a number of demands were raised, but we are taking up the following issues for consideration of the Administration: -

- i) Providing of space in U.T. Secretariat for holding monthly meeting, as per convenience and availability thereof, as it will give us a chance to interact with our younger brothers. In case, they have any problem with regard to any issue, we will be there to help them also.
