No. 50629.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Government of India, Ministry of Home Affairs, notification bearing No. S.O. 3267, dated 1st November, 1966, the Administrator, Union Territory, Chandigarh is pleased to make the following rules and further to amend the Government Medical College and Hospital, Chandigarh, Chief Physiotherapist, Group 'B' (Non-Ministerial), in Government Medical College and Hospital, Chandigarh, Recruitment Rules, 2002 namely :—

1. **Short title and commencement.**—(i) These rules may be called the Government Medical College and Hospital, Chandigarh, Chief Physiotherapist, Group 'B' (Non-Ministerial) (1st Amendment) Rules, 2017.

(ii) They shall come into force on the date of their publication in the official gazette.

2. In the said rules, against the post of Chief Physiotherapist, shown at Sr. No. 45 in Schedule appended to these rules, for the Column No. 3, 4, 5, 10 (old) and 9 (new), 11 (old) and 10 (new), 12 (old) and 11 (new) and 13 (old) and 12 (new) the following shall be substituted :—

Column-3 General Central Civil Services Group 'B' Non-Ministerial

Column-4 Pay Band ₹ 10,300—34,800 + Grade Pay ₹ 4,200

Column-5 Selection

Column-10 (Old) 9 (New) 2 Years

Column-11 (Old) 10 (New) By Promotion failing which by deputation including Short-Term Contract

Column-12 (Old) 11 (New)

Promotion :

From amongst the Senior Physiotherapist in PB ₹ 10,300—34,800 with grade pay ₹ 3,600 having 3 years regular service in the grade after appointment thereto.

Note.—Where juniors who have completed their qualifying/eligibility service are being considered for promotion. Their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service, or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade alongwith their juniors who have already completed such qualifying/eligibility service.

By Deputation (Including Short-Term Contract) :

Officers under Central Government/State Governments/Union Territory Administrations/Public Sector Undertakings/Universities/Recognized Research Institutions/Semi Government Or Autonomous Bodies/Statutory Organizations:

(A) (I) Holding analogous post on regular basis in the parent cadre/department ;

or

(II) With three years' regular service in PB : ₹ 10,300—34,800 with grade pay of ₹ 3,600 or equivalent in the parent cadre/department ;

or

(III) With six years regular service in PB : ₹ 5,200—20,200 with grade pay of ₹ 2,800 or equivalent in the parent cadre/department ; and

(B) Possessing the educational qualification and experience as under :

(I) Bachelor's degree in Physiotherapy from a recognized Institute/University ; and

(II) Two years experience in the relevant field from a recognized hospital/institute.

Note 1.—The departmental officer in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationists shall not be eligible for consideration for appointment by promotion.

(The period of deputation (ISTC) including period of deputation (ISTC) in another ex cadre posts held immediately preceding this appointment in the same or some other organizations/department of the Central Government, shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of receipt of applications).
