**NOTICE REGARDING SCHEDULE AND PROCEDURE FOR CONDUCT OF ONLINE
SECOND COUNSELING FOR ADMISSION TO MD/MS COURSES-2024**

Schedule for **PG Second Counseling** for admission to MD/MS courses-2024 is as follows: -


Period for seat surrendering allotted in First Counselling	05.12.2024 to 12.12.2024 till 10:00 PM
Display of seat matrix for Second Counseling	13.12.2024
Online filling & locking of choices (MD/MS) for Second Counseling	16.12.2024 to 21.12.2024 till 5:00 PM
Display of result for seat allotment in Second Counseling	23.12.2024
Reporting, Verification of documents, Medical Examination and submission of fee of selected candidates in Second Counseling	24.12.2024 till 4:00 PM

1. The revised schedule mentioned above is subject to change by competent authority/NMC/Hon'ble Courts. (To be notified on the GMCH website in case of any change).
2. The candidates who have been allotted seat/have reported for admission after the First state counseling (i.e. IP and UT Chandigarh Pools) have to surrender their seat via online mode by 12.12.2024 till 10:00 PM to participate in Second Counseling. Such candidates who surrender their allotted seat/reported for admission seat have to fill choices/preferences as per above given schedule to participate in second counseling.
3. Candidates who have not been allotted any seat in the first counseling shall remain eligible for second counseling as per schedule subject to filling of choices/preferences as per above given schedule.
4. **Candidates who have been selected & holding the MD/MS seat from All India Quota (AIQ) or State quota anywhere in India will not be eligible to participate in second round of State Counselling in the GMCH-32, Chandigarh. All candidates opting for second counseling shall ensure that at the time of locking of choices for Second Counseling, he/she is not holding any seat of MD/MS in All India Quota or any other State Quota. All candidates filling choices/preferences for second counselling have to agree to an undertaking that "I am not holding any MD/MS seat from All India Quota (AIQ) or State quota anywhere in India. I further agree that in case if at any stage it is found that I was holding such a seat at the time of filling choices, my admission will be cancelled and same shall be intimated to MCC/Concerned State Authorities/NMC for further necessary action.". This undertaking will be included in the form for filling choices/preferences.**



5. As mentioned in the prospectus, conversion of vacant reserved seats (EWS/PwBD/SC) /IP Pool to UT Chandigarh Pool, if any, shall take place in Second Counseling. Candidates should note that seats, after conversion of seat remaining vacant if any, shall also be available to them and allotted as per choices/preferences already filled (by 21.12.2024 till 5:00 PM). They should exercise due caution while filling choices/preferences as mentioned above.

The steps for conversion of seats shall be as per the PG Prospectus – 2024, (Clause No.13 to 16 P.No.22).
