Clarification

This is in reference to circular no. 3321-3455/FC dated 10.07.2018 regarding the fee to be deposited by SC students belongs to Punjab, eligible for Post Matric Scholarship (PMS).

In this regard, it is further clarified that the conditions/criteria which were applicable in the previous academic session (2017-18) shall continue to be applied in this semester of 2018-19 also as follows;

1. The aforesaid circular is only applicable to the SC students belonging to State of Punjab (having annual family income not more than Rs. 2.50 lac and eligible for PMS).
2. The concerned SC students shall submit a self attested undertaking regarding his/her family annual income at the time of admission.
3. In case of traditional courses or normal, such SC students of Punjab need not pay any fee except refundable component, such as library security etc.
4. In case of self-financing courses such students must deposit 25% of the total fee of that semester (excluding examination fee) at the time of admission.
5. Before allowing the benefit of above circular to eligible SC student of Punjab, the eligibility of such students as per PMS scheme must be checked by the concerned department and ensured that such students must submit Post Matric Scholarship form in the office of SC/ST cell for onwards submission to Government of Punjab before due date, failing which concerned SC student of Punjab have to pay entire fee along with interest due on the fee. Related undertaking regarding the submission of PMS form may be taken at the department level.
