No. n In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with Ministry of Home Affairs Notification bearing No. SO. 3267 dated 01.11.1966, the Administrator, Union Territory, Chandigarh hereby makes the following rules for regulating the method of recruitment of Non-Ministerial Cadre Group 'C' posts in the Govt. Medical College & Hospital, Chandigarh, namely:-

1. **Short title and commencement:** (1) These rules may be called the Govt. Medical College & Hospital, Chandigarh, (Non-Ministerial Cadre Group 'C' posts) Recruitment Rules, 2014.

(2) They shall come into force on the date of their publication in the official gazette.

2. **Application:**

These rules shall apply to the posts specified in column No.1 of the Schedule annexed to these rules.

3. **Number of posts, Classification & scale of pay: -**

The number of posts, their classification and the scales of pay attached thereto shall be as specified in Columns (2) to (4) of the said schedule annexed to these rules.

4. **Method of Recruitment, age limit and other qualifications: -**

The method of Recruitment, Age limit. Qualification and other matters connected thereto shall be as specified in Column no (5) to (13) of the said schedule

5. **Disqualifications: -** No person,

(a) who has entered into or contracted a marriage with a person having a spouse living, v or

(b) Who, having a spouse, living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Administrator, Union Territory, Chandigarh may, if satisfied, that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing exempt any person from the operation of this rule.

6. **Powers to Relax:-** Where the Administrator, Union Territory, Chandigarh is of the opinion that it is necessary or expedient so to do, he may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules in respect of any class or category of persons.

7. **Savings: -** Nothing in these Rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
