**IMPORTANT NOTICE**

This is for the information of all the candidates who have already submitted their online application and paid application fee that online portal will be functional for the following from 10:00 A.M on 20.11.2024:

**1. RECTIFICATION AND SUBMISSION OF DEFICIENT DOCUMENTS.**

Due to the representation by the candidate on issues such as non-availability of NEET PG Marks in NEET PG 2024 result card, and deficiency of documents as displayed on GMCH website in list uploaded on 18.11.2024, the PG Committee of GMCH has decided to allow candidates who have already submitted their online application and paid application fee to rectify /submit deficient documents. For this purpose, candidates can assess already submitted application form by using their existing login id and password and carry out the rectification as well as submit the deficient documents. All candidates are advised that they should carefully read the application form and ensure that they have rectified all the mistakes and submitted the deficient documents. It is further clarified that the form resubmitted after rectification and submission of documents will be treated as final application form and candidates will be declared eligible /ineligible for different pools / categories based on the information provided and document submitted. Where candidates choose not to carry out any rectification or no deficiency has been pointed out their already submitted application form will be treated as final.

**2. ONLINE COUNSELLING:**

In reference to directions issued by National Medical Commission, New Delhi vide press release No. N-P011(20)/20/2023-PGMEB-NMC dated 08.11.2024 (Annexure I) whereby all rounds of counseling for all seats by **ONLINE MODE** by State or Central Government counseling authority has been made compulsory, GMCH authorities have decided to carry out online counselling instead of physical counselling as advertised in the Prospectus for Admission to MD/MS Courses (Session 2024). For online counselling, the candidate will be able to fill their choices online as per the revised schedule (Annexure II). From the day choice filling is available, candidate shall login by using their existing login id and password and follow the following procedure:

**Procedure to enter choices for online counseling for Admission to MD/MS Courses  
Session-2024**

- Click on link available on GMCH website for enter of choices/preference of MD/MS Courses, 2024 (Part-II)  
↓
- Login by using already registered login id and password  
↓
- Click on **“ENTER YOUR CHOICES/PREFERENCES”**  
↓
- Select specialties in order of your choice/preference of courses (MD/MS)  
↓
- Candidate can change order of choice/preference by using **“UP/DOWN ARROW”** button.  
↓
- Click on **“SAVE”** your choices/preferences  
↓
- Candidate can still change order of their choices/preferences by **“UP/DOWN ARROW”** before locking  
↓
- For final submission of choices/preferences and their order of preference press on the **“LOCK THE CHOICES”**. After locking, choices/preferences and their order cannot be changed.

- Candidate can **“PRINT”** the final document of his choices/preferences and their order opted and keep it for record.

### PRESS RELEASE

Subject: Counseling for NEET PG-2024

National Medical Commission has notified the "Post Graduate Medical Education Regulations, 2023" (PGMER-2023) on 29<sup>th</sup> December, 2023. Chapter IV of PGMER-2023 deals with admission, counseling, etc. for PG medical courses. Salient features of the Regulations are as under:

- Admission to the PG Courses shall be through counseling by the Government agency based on the merit list of the NEET PG exam.
- All rounds of counseling for all seats will be held on online mode by state or central Government counseling authority and no medical college/ institution will admit any candidate themselves.
- Any student admitted in contravention of these Regulations will be discharged from the course and double the number of seats shall be reduced for one or more years.
- All the permitted PG seats in a medical college/ institute are to be considered as recognized seats for the purpose of registration of additional qualifications

2. The Medical Counseling Committee (MCC) has published the schedule of NEET PG counseling for the academic year 2024 to be conducted by MCC, DGHS and State PG Counselling agencies in their respective State.

3. All the stakeholders are requested to go through the PGMER-2023 and also through the number of PG seats available to each medical college/ institute on NMC's website before taking admissions to the PG courses.


