## CIRCULAR

In continuation of previous Circular Endst. GMCH/Estate/II/2022/19262-75 Dated 11.05.2022 it is again bring to the notice of all concerned that to further strengthen the management of Biomedical waste, the following steps need to be strictly followed:

- Do Not dump the Bio Medical Waste in estate sewer of M.C Chandigarh. Which is not only injurious to Sewermen but contrary to the provision of Bio-Medical Waste Management Rules, 2016.
- Segregation of the waste is the responsibility of the waste generator (staff working in various wards/ OPDs/Labs/ OTs etc.). Waste should be segregated in color coded bags as per the rules at the site of generation. Unsegregated waste will attract punishment under the waste management rules.
- The bags of segregated waste should be labelled with the name of area from where it is being generated.
- The sister-in-charge of the ward/areas and in-charge technician in labs will ensure the segregation of waste, labelling of bags and timely packing of bags.
