No. GMCH/1EA2/12(5)86/2019/26145.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with Government of India, Ministry of Home Affairs, notification bearing No. S.O. 3267, dated 1st November, 1966, the Administrator, Union Territory, Chandigarh is pleased to make the following rules and further to amend the Government Medical College and Hospital, Chandigarh, Driver, Group-'C' (Non-Ministerial), in Government Medical College and Hospital, Chandigarh, Recruitment, Rules-2002, 2014 namely:—

- 1. (1) Short title and commencement.—(i) These rules may be called the Government Medical College and Hospital, Chandigarh, Driver, Group-'C' (Non-Ministerial) (2nd Amendment) Rules, 2019.
  - (ii) They shall come into force on the date of their publication in the official gazette.
