- Incomplete applications or applications not accompanied by relevant documents will be summarily rejected.

- The candidates will initially be shortlisted based on the qualification and the work experience. If number of candidates are more, a written test might be taken. **The list of shortlisted candidates for the interview shall be displayed on the website.** Interview for post will be held in **PIA Room, Block D, Level 2, Room no. 226, GMCH, Chandigarh.** **The list of selected candidates shall also be displayed on the GMCH website.** No TA/DA will be paid for attending the interview. Bring the hard copies of all certificates on the date of interview.

- Tenure: The assignments are purely on contract basis for a period of twelve months extendable to three years in ESCHAR Trial and for a period of six months in SPLID Trial respectively. These appointments will be made from the staff strength sanctioned under ICMR project and the appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in GMCH 32/DHR/ICMR or continued contractual appointment.
- Expiry of contract: The contract will automatically expire on completion of twelve months or earlier in case of withdrawal of support by funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
