Notification

The 10th December, 2015

No. NVBDCP/SA/9928.—Whereas the Administrator, Union Territory, Chandigarh is satisfied that the Epidemic Disease Act, 1897 empowers the State Government to take special measures and prescribe regulations as to dangerous epidemic disease.

And whereas, the Administrator, Union Territory, Chandigarh is of the opinion that in consultation with the Central Government the U.T., Chandigarh has ascertained that the spread of influenza A H1N1 constitutes a dangerous communicable disease which has the potential of assuming epidemic proportions unless special measures are taken to regulate the movement of person's infected with influenza A H1N1 virus in the U.T., Chandigarh.

Now therefore, in exercise of the power conferred by sub-section (1) of Section 2 of the Epidemic Disease Act, 1897, the Administrator, Union Territory, Chandigarh hereby declares Swine Flu as a notifiable disease under the jurisdiction of Chandigarh and Chandigarh to be a threatened area.

Therefore, the Administrator, U.T., Chandigarh hereby further directs that the DH&FW and/or his representative/s Incharge Isolation Ward-PGIMER-12, GMCH-32 and GMSH-16, State Surveillance Officer, Anti Malaria Officer and State Epidemiologist shall be empowered to take all necessary steps to ensure enforcement of the Epidemic Disease Act and Control of Swine Flu.
